SUPPLEMENTARY AGENDA ITEM 1. Broken Cross Chrildren's Centre Consultation

Mark Stanley, CEC Locality Manager, and Nigel Moorhouse, CEC Director of Children's Services, presented details associated with the engagement and consultation process being undertaken by CEC with regard to Broken Cross Children's Centre. It was clarified that the facility was not being proposed to close, but it has been proposed to de-designate the facility as a Children's Centre to achieve financial savings.

Members sought clarification as to the impact on services at the centre and were assured that the centre would continue to offer the range of services currently on offer to families needing them.

Members commented that with a positive engagement process came some misunderstanding and perhaps the communication process could be improved on in the future.

- iv. That this funding will be subject to a formal Service Level Agreement

- i. That £12,000 is granted from the 2015/16 Grants budget for the delivery of support and engagement services in Macclesfield.
- ii. That this grant is a single award and not the basis of an annual agreement.
- iii. That this funding will be subject to a formal Service Level Agreement
