Apologies were received from Cllr Gareth Jones (and Cllr Philip Bolton, although not a member of the committee, had hoped to attend for the discussions relating to agenda item 8)

2. DECLARATIONS OF INTEREST

Cllr Dooley declared a non-pecuniary interest in Item 4, having previously volunteered for the festival on an informal basis.

3. MINUTES OF THE MEETING OF THE FINANCE COMMITTEE ON 19TH AUGUST 2015

4. BARNABY FESTIVAL FUNDING APPLICATION

Lynn Jones gave a detailed overview of the festival, answering questions from the committee. It was highlighted that the festival had been successful at securing public sector funsing which in turn had leveraged additional external funding. It was clarified that the spend during the event accounting year was not linear and this explained why there was a current surplus although it was further clarified that this was not a true picture of the exact bottom line for reserves, which were much less.

Details of the work to be carried out in the community were shared with the committee including in the Weston, Moss, Upton Priory and Broken Cross greas of Macclesfield.

Details associated with the staffing costs were clarified to explain the requirement for paid as well as significant volunteer support.

The benefits to the town were detailed such as the direct economic benefit of estimated £400,000 spend in the town as well as the 13,000 additional visitors.

Members discussed at length the options for and benefits of funding the project, as well as the risks of funding to the full requested amount of £10.000.

Lynn Jones was thanked for all the hard work she and her colleagues working on the Barnaby Festival have done.

Resolved: That this committee recommends to Full Council a grant of £10,000 to the Barnaby Festival
