6. NEIGHBOURHOOD DEVELOPMENT PLAN

Members discussed the circulated information at length and discussed the potential perceived value of a Neighbourhood Development Plan (NDP) as well as the possible lack of influence, impact and value. Members identified the risks to funding and concerns relating to the CEC Local Plan (as yet unadopted)

The discussion identified a lack of support for the recommendations within the report and members sought an alternative positive approach to local planning strategy.

It was agreed that the Town Clerk should return to this meeting with a draft brief detailing the requirements of a role to deliver detailed research information in to developable sites within the Macclesfield town boundary.
