### **3. CHAIRMAN AND VICE-CHAIRMAN**

#### **3.1 Elect the Chairman of the Finance Committee**

#### **4. CO-OPTION**

#### **5. FINANCIAL REGULATIONS**

The Town Clerk reminded the committee that the Financial Regulations were adopted by full council on 21/5/15 and that any substantive amendments to the document would require Full Council ratification. Some typographical amendments were highlighted by councillors.

**Resolved:** That the typographical amendments be made and the document be reviewed in 6 months to ensure it remains relevant to the operation of the council.

#### **6. INTERNAL AUDITORS**

The Town Clerk made the committee aware of some Macclesfield-based auditors and updated members with the responses so far. Members identified that there was little interest from the local firms.

**Resolved:** That JDH Business Solutions Ltd is appointed as the internal auditors for the Town Council.

#### **7. CHRISTMAS LIGHTS**

Members were asked to note the budgeted figure for Christmas Lights. Members discussed the means of provision of Christmas Lights, past work of Make it Macclesfield and the short timescale available to make a significant impact. Members were supportive of the Christmas lights and commented on the hard work of those who had ensured the Town Centre had a Christmas Lights display in previous years.

It was noted that the Town Council did not own any Christmas Lights and these assets were held by Make it Macclesfield.

**Resolved:** That the management of the Christmas Lights budgetary spend be delegated to the Services Committee

#### **8. MEMBER ITEMS**

##### **8.1 Remembrance Sunday Parade**

Cllr Hardy circulated a report relating to this item and highlighted the value of the event and its support within the town, along with the costs associated with the provision of the event.

**Resolved:** That a budget of £3,500 is made available for the event from the "Contingency" budget line.

## **8.2 Remeberance Day Service**

Cllr Hardy circulated a report relating to this item and highlighted the value of the event and its support within the town, along with the costs associated with the provision of the event.

**Resolved:** That a budget of £750 is made available for the event from the "Contingecy" budget line.

## **9. OFFICE ACCOMMODATION AND INFRASTRUCTURE**

The members took the opportunity to view the Tatton Room within the Town Hall, which has been muted as the available office space that Cheshire East Council will make available for an annual rent of £8,500. Members discussed the benefits of the location, space available and accessibility of the Town Hall and the Tatton Room.

**Resolved:** That the Town Clerk is delegated to continue negotiating the provision of office accommodation within the Town Hall and to bring draft heads of terms for consideration to this committee for approval.
