Mr Alec Johnstone raised the issue of the need for investment in highway infrastructure as the town centre suffered from high than national average pollution levels due to traffic density.

Mr Johnstone went on to clarify that the town would benefit from a bypass, which he felt should be a condition of any future large scale planning applications in the south and west of the town to alleviate the impact of traffic on air quality and delays.

Members welcomed Mr Johnstone's detailed understanding of the situation and discussed at length opportunities to progress such a

scheme, recognising the Town Council's limited capability to dictate highways infrastructure policy and provision.

It was highlighted that recent strategic meetings within Cheshire East Council had identified the same issue and were seeking to address the problem in a similar means to those suggested by Mr Johnstone.

The Town Clerk clarified the discussion for the benefit of clarity and Mr Johnstone confirmed he was happy with the discussion and that no further response or action was required from the Town Council at this time.

Following this, the Chairman reconvened the Planning Committee Meeting.
