6.1 Macclesfield's Plaques.

Cllr Puttick gave an update on the project's progress, recent engagement and future plans for further engagement. It was highlighted that, although the project has a budget, all planned spend must be agreed prior to placing any orders or commitments.

Members expressed support and thanks as well as interest in providing personal memories of Macclesfield for the project.

6.2 Town Centre Wifi

It was noted that the service is in place and also includes detailed footfall data.

6.3 Pocket Parks & Fruitful Communities

It was noted that the first park has been delivered with the help of volunteers from the Macclesfield Garden festival. The raised planting area at the exit of the bus station was completed during Barnaby and is now being watered by ANSA

6.4 Train Station Welcome Art

The shortlisted tenders were consulted on during the Barnaby Festival both digitally as well as with a display in the Grosvenor Centre.

A meeting of the panel is being arranged to review the responses and agree a preferred provider for appointment. Following that, the artists will engage with the community, within the brief, to develop a draft design prior to planning consent and installation.

Currently Cheshire East Council is communicating with Network Rail to clarify responsibility for the wall.

6.5 Sparrow Park Interpretation

Cllr Schofield has been working voluntarily on the vector images and photography for this project. Once available, they will be shared with the engaged interpretation consultant to deliver draft interpretation design.

The Support Officer is co-ordinating the delivery of this service for summer 2018.

11.1 Public Realm Furniture

It was noted that the work on public realm furniture is continuing with planters and bins having been painted. It was agreed that those flyposting in town should be contacted to request the removal of the posters.
