

Proposed H3G & EE 6No. RRU, 5No. Mk2 BOBs and 6No. Routers on new RRU Frames to be installed. Proposed H3G & EE Equipment Cabinets to be on new Concrete Plinths. Proposed H3G & EE Mk5 AC Link Cabinet to be installed on new Concrete Plinth. New Sub Main from GP6 Meter Cabinet.
