Briefly describe what the grant you are requesting is required for and why it is needed (maximum 150 words):	Children and young people with disabilities continue to face barriers to social and leisure activities. Distance from opportunities, lack of self-belief, lack of appropriate facilities and negative experiences can lead to isolation and loss of independence. Longer term this negatively affects self-confidence and

transition to adulthood.

We can address some of these disadvantages by providing a weekly drama group for local children and young people with disabilities across Macclesfield to help improve their confidence, mental health and wellbeing, skills and independence – whilst having fun! Through carefully designed activities and performances, delivered by an applied drama practitioner, and supported by local volunteers, local disabled children feel more part of their local community and much less isolated and excluded.

- We will equip at least 32 children and young people with disabilities in Macclesfield with the skills and independence to try new leisure activities, make friends and feel more confident participating more fully in their local community.
- They will have fun, feel more positive and feel less isolated.
- We will raise aspirations by showing disabled young people they can pursue a career in the performing arts sector.
- Parents/carers will get some much needed respite from their caring role.
- Increased leisure opportunities will increase social integration in Macclesfield and develop community activity by bringing more people together.
- The small business who provides the drama coaching will benefit from increased revenue, as will the college providing space for us, stimulating the local economy, as well as become more 'disability aware'.
- We will continue to use volunteers at this club and promote our volunteering programme locally.

We will sustain these activities by continuing to apply to other grant funders such as the Edward Gostling Foundation and the Russell Trust. We also raise funds through community fundraising and events such as the Run North West Knutsford 10K. Families make a small contribution to help cover some costs.
