The shop front – all wooden frames – needs stripping / sanding and repainting to correct weather damage and update the colour to a heritage forest green. This will be in-keeping with the character and age of the building. (Ben Johnson - £540)

The branding will be sign-written onto the fascia using traditional methods, inkeeping with the historic nature of the building. This will be done in the Loola Loves brand purple which compliments the green very well (as seen in my existing shopfront at number 67 Chestergate). (Gregg at Cactus Sign Painting -£600)

Shop opening hours will be painted onto the window which will add a classic touch to the frontage, rather than a printed poster of sign hung internally.

The above works will enhance the shop front, it's appeal to passing customers and be in-keeping with neighbouring businesses — Windyways and Déjà vu.

3.3 Estimated total cost of project:

We will require 2 quotes for each aspect of work.

Signwriting / signage quotes :

£600 – signwriting to fascia and windows by Gregg at Cactus Sign Painting

£816.68 with £135.00 fitting all + vat – flat cut lettering, backing and installation by Signs Express, Macclesfield.

Preparing & painting shop frontage / frames quotes :

£540 for labour - Ben Johnson (Painter / Decorator)

£920 labour plus materials - P J Cody (Painter / decorator

I have chosen to hire Cactus Sign Painting for the signage and Ben Johnson for preparing and painting the wooden shop front. I will put the full grant towards the total cost and pay the remainder myself.
