Briefly describe what the grant you are requesting is required for and why it is needed (maximum 150 words):	As we know, loneliness is a silent killer and our B&B project is an impactful intervention, ensuring that the loneliest people in our community speak to someone at least once a week. Our support is for those aged over 18 but we mainly support those aged 60 + with the majority of our clients being 65 years and over. Our telephone service is a vital lifeline, offering companionship and emotional support that greatly improves mood, mental health, and overall wellbeing. For those who are housebound, these

	calls provide a powerful connection to the outside world and a genuine sense of care. The grant is needed to continue to provide this essential service and to expand our reach to even more individuals at risk of chronic loneliness and social isolation. With your support, we can ensure that no one in our community feels forgotten or alone.

By providing regular telephone support to the current 48 clients in Macclesfield and our efforts to continue to support many more, we will help to reduce loneliness and social isolation among vulnerable individuals in Macclesfield particularly older adults, carers, and those living alone. Building on the success of this service, we have recently expanded our offering with group sessions. These groups serve as a natural extension of our phone calls, providing a safe, welcoming, and non-judgemental space for those ready to take the next step towards in-person interaction. This improves overall wellbeing by providing regular emotional support, companionship, and connection, strengthens community ties by linking individuals to local groups, services, and volunteer-led activities.
